

## Where to seek legal advice

The Queensland Civil and Administrative Tribunal (QCAT) is an independent tribunal that resolves disputes in a manner that is accessible, quick and inexpensive.

Due to the tribunal's independence, registry staff cannot provide legal advice. Common questions we are asked which we cannot answer include:

- Should I submit an application?
- Can the tribunal manage my dispute?
- How do I word my application?
- What evidence do I need to prove my case?
- What should I say in my hearing?
- What orders do I need to ask for?

You may wish to seek legal advice for answers to these questions.

### Obtaining legal advice

There are a number of options for obtaining legal advice.

The service operates on a drop-in basis, at a number of different times each week (subject to the availability of volunteers).
