- 1. The following definitions apply to this proposed agreement:
 - (a) "the neighbour" Darren John Hadfield
 - (b) "the tree keeper" Elizabeth Elliston Budgen
 - (c) "the neighbours property" 94 Berry Street, Sherwood QLD 4075
 - (d) "the tree keeper's property" 38 Prospect Street, Sherwood, QLD 4075
 - (e) "the trees" bamboo
- 2. The tree works are as follows ("the works"):
 - (a) The tree to be maintained at a height of 5 metres from ground level on a six monthly basis.
- The tree keeper will pay the cost of the works.
